The eastern portion of the property falls within the Agricultural Land Reserve (ALR) which will require that portion of the site to have an OCP amendment to Agricultural.</p> <p>The purpose of Bylaw No. 1897 is to amend the City of Langford Zoning Bylaw No. 300 by amending the text of the RR4 (Rural Residential 4) Zone to allow a truck terminal facility at 2981 and 2985 Awsworth Rd.</p> | | |

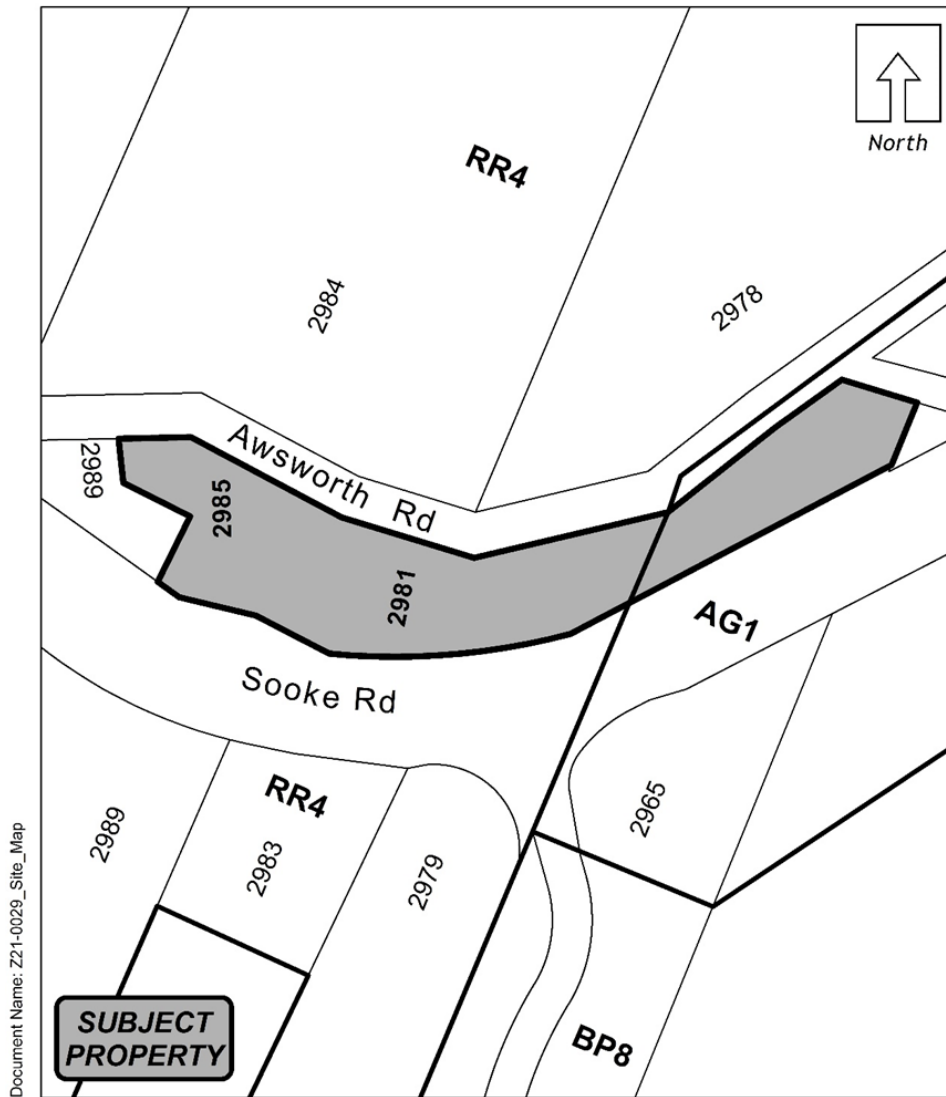
