## CITY OF LANGFORD BYLAW NO. 2017

## A BYLAW TO AMEND BYLAW NO. 300, "LANGFORD ZONING BYLAW, 1999"

The Council of the City of Langford, in open meeting assembled, hereby enacts as follows:

- A. Langford Zoning Bylaw No. 300, 1999 is amended as follows:
  - 1. By deleting from the One- and Two-Family Residential (R2) Zone and adding to the City Centre 1 (CC1) Zone the properties legally described as:
    - Lot 6, Section 73, Esquimalt District, Plan 19804, PID No. 003-637-743 (791 Revilo Place)
    - Lot B, Section 73, Esquimalt District, Plan 18886, PID No. 003-795-713 (795 Revilo Place)
    - Lot 3, Section 73, Esquimalt District, Plan 18591, PID No. 003-757-722 (2931 Phipps Road)

in the portions as shown shaded on Plan No. 1 attached to and forming part of this Bylaw.
